- to act as fiscal agent in Germany and fulfill all tax duties for VAT purposes arising from intra-Community delivery of our goods after these being customs cleared,
- to file the tax return according to § 22b, section 2, sentence 1 of the German Value Added Tax Act,
- to submit the Summary Report according to § 22b, section 2, sentence 3 of the German Value Added Tax Act,
- to fulfill the general recording duties according to § 22b, section 3 of the German Value Added Tax Act,
- to add to invoice the information according to § 22c of the German Value Added Tax Act,
- to submit the Intrastat Report to the Federal Statistical Office of Germany.

3. We guarantee that we fulfill the conditions according to § 22a, section 1 of the German Value Added Tax Act.

4. We commit ourselves to inform KUNOW immediately and in written form about any changes concerning validity of our VAT-ID-No.

5. We are fully liable (also without our fault) for the completeness and correctness of all submitted information necessary for the execution of all orders.

6. We guarantee that the goods are dispatched as intra-Community delivery to another EU member state immediate after the fiscal customs clearance. After delivery we immediately and unrequested will provide proof of delivery to KUNOW. This has to be in the form of a CMR signed and stamped by the consignee of delivery receipt.
